Unified Champion Schools (UCS) is a strategy dedicated using inclusive sports opportunities as a catalyst for social change. In addition to inclusive sports the UCS strategy brings students with and without intellectual disabilities together through inclusive leadership programs and whole-school engagement opportunities. SOUT currently has one or more of the UCS components taking place in 47 high schools, 2 middle schools and 75 elementary schools throughout Utah.

Season Sports

Special Olympics Utah (SOUT) is a leader in providing year-round sports training and competition for children and adults with and without intellectual disabilities. Through the support of community-based volunteer coaches, SOUT offers training and competition in year-round season-appropriate sports. Sports include snowshoeing, basketball, track and field, cheerleading, softball, swimming, bowling, cycling, bocce, dance, flag football, golf, and soccer.
